Dear Caring Adult,

LiftUp partners with our schools to offer a supply of nutritious snacks for children during the school week, FREE OF CHARGE. Any child is eligible to participate in this program if the child qualifies for the Free/Reduced Lunch Program, if the child's parent or guardian currently receives food or services from LiftUp or from the Department of Human Services, or based on the answers to the questions on the reverse. Any adult can register any child in participating schools or organizations for this program, as long as the child qualifies. If you are unsure if a child qualifies, you may contact us at LiftUp; we can help you determine a child's eligibility.

We believe that the nutritious classroom snacks we are going to provide will help us better meet our goal to support the health, well-being and performance of Routt County's school-aged children by ensuring that they are not preoccupied with hunger.

When the Rocket Pack Snack Program starts, classroom teachers will hand out snacks each day during the school week to participating students. Those students will continue to receive snacks until the end of the school year, or until they opt out of the program.
